#### LOCATION

Kilmarnock is one of the larger towns in Ayrshire with over 46,000 residents and an East Ayrshire catchment of 122,000 persons. The town lies on the A/M77 extending north to Glasgow (24 miles) and south to Ayr (18 miles).

Academy Street is located south of Kilmarnock Town Centre within an established industrial area with nearby access on to the A77, A71 and A76 road routes. The location offers the following drive times:

#### **DESCRIPTION**

The property consists of a large industrial yard of irregular shape and taking direct access off Academy Street leading to Low Glencairn Street, a main road route within Kilmarnock Town Centre.

The site is level, secure and surfaced with services understood to be on site. The site has the rare benefit of a rail head access extending to the national rail network.

The site has potential for sub-division into smaller lot sizes to suit occupier demand.

The yard extends to 1.23 Ha (3.04 Ac), or thereby.

#### **RATING**


The Rateable Value is £28,000 and would be reassessed if the yard were to be sub-divided.
