The unit is situated on the East side of Buko Industrial Estate and is accessed directly from Dalton Road.

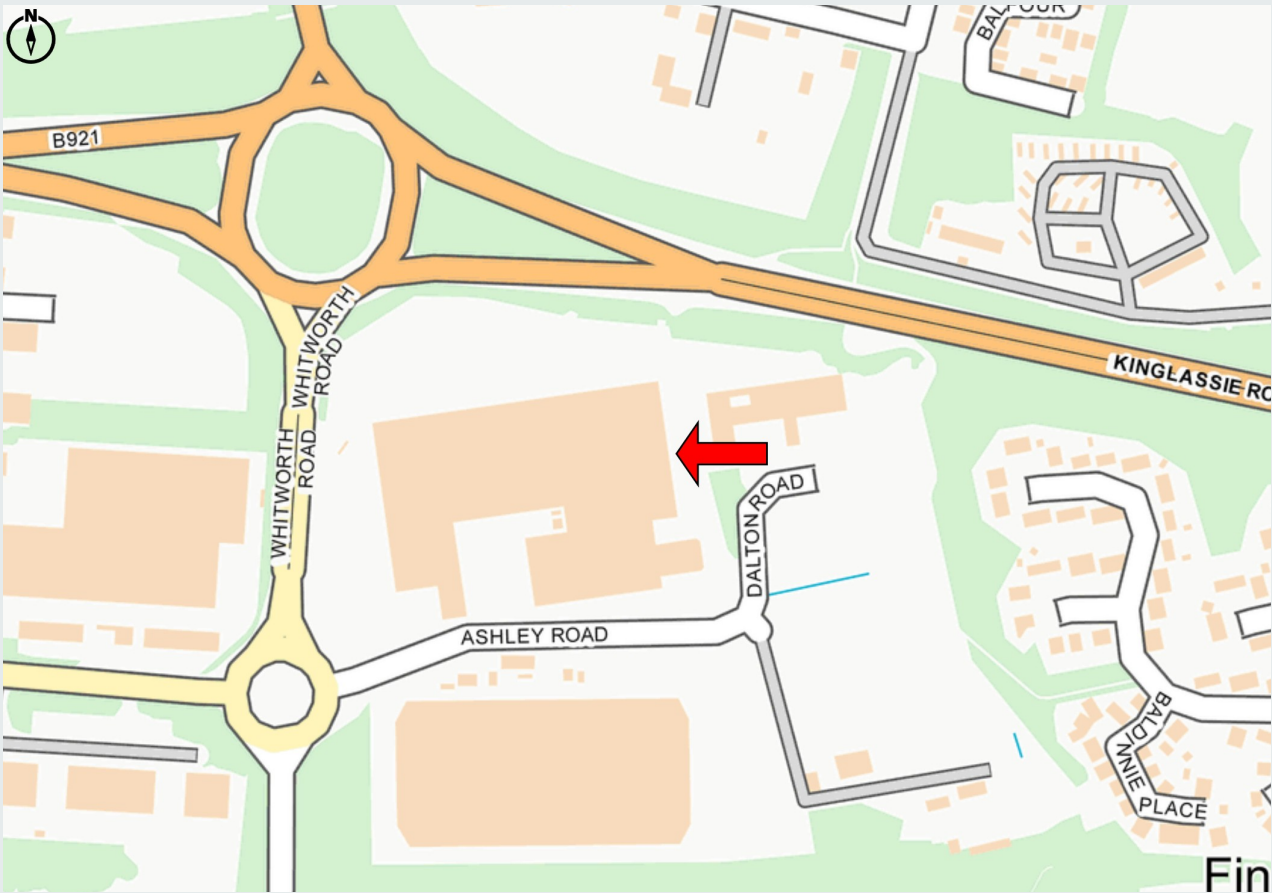
The subjects comprise a steel frame, benefitting from the following specification: -

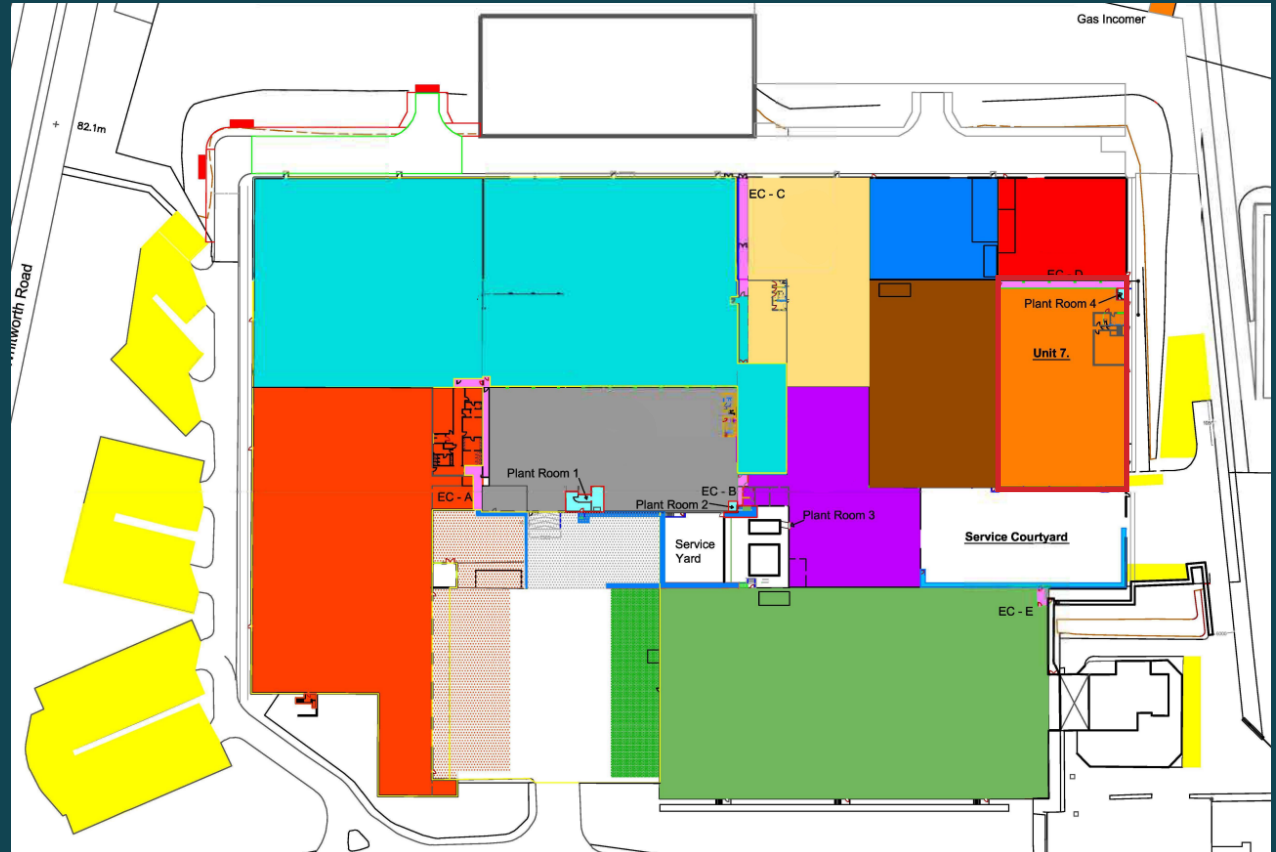
