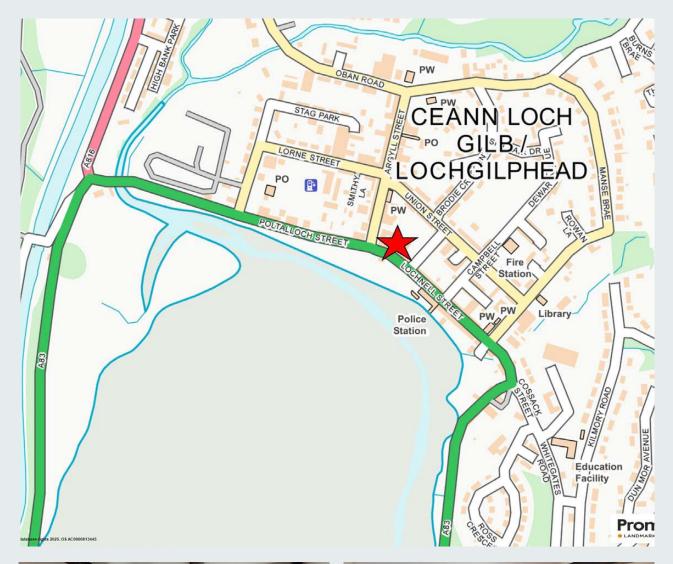
#### **LOCATION**

Lochnell Street, is a main road route in Lochgilphead forming part of the A83, and is a mixed commercial and residential locale with the building having an outlook on to Loch Gilp with views to the Kintyre Peninsula.

Lochgilphead is in the Argyll and Bute region and has a population of around 2,300 persons. The town is on the A83 which extends south to Campbeltown (50 miles), north to Oban (37 miles) and east towards Glasgow (90 miles) via the A82.

#### **DESCRIPTION**

'The Comm', is a former public house premises contained over four floors within a category C listed, mid terraced building of traditional construction. The building contains a traditional pub house premises at ground floor level, extending into a rear projection and with a detached cellar store to the rear garden area. The first floor is a former function room and a kitchen, with two former letting rooms and a bathroom on the second floor and a single storage room at attic level. The building requires modernisation throughout.
